Subject:- Grant of Conditional Permission to Shri Ramchandra Vaidya Ayurvedic Medical College and Hospital, Yamuna Vihar, Malhaur Road, Near Eldico Tiraha, Chinhat, Lucknow-226028, Uttar Pradesh (Inst. ID-AYU0367) with intake capacity of 60 seats in UG (BAMS) course for the academic session 2024-25 under section 28 of NCISM Act, 2020 and relevant regulations thereunder -regarding.

Sir/Madam,

With reference to the subject mentioned above, I am to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act,1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021.

- Further, to assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities at your college namely Shri Ramchandra Vaidya Ayurvedic Medical College and Hospital, Yamuna Vihar, Malhaur Road, Near Eldico Tiraha, Chinhat, Lucknow -226028, Uttar Pradesh (Inst. ID-AYU0367), inspection of your college was conducted on 11.03.2024 & 12.03.2024 and visited again on 04.04.2024 & 05.04.2024 on hybrid mode as a part of annual visitation by the visitation team of Medical Assessment and Rating Board, NCISM to process the Conditional Permission with intake capacity of 60 seats in UG (BAMS) course for the academic session 2024-25 under section 28 of NCISM Act, 2020 and relevant regulations thereunder.
- 2. Further, the hearing with regard to faculty suspected to be working only on paper but physically not present was conducted on 26.06.2024 & 27.06.2024 and recommendation of the hearing committee was placed in the 96th Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on 05.07.2024. The same was approved that six of your faculty who were suspected to be working only on paper, namely Dr. Chhaya T. Munde (AYKS00517), Dr. Dheeraj S. Pai(AYSS00166), Dr. Gajanan Arjunrao Dhole (AYSV00407), Dr. Mayur Ankush Khapare (AYAT00750), Dr. Roopa D. Pai (AYDG00829) & Dr. Savita Choudhary (AYPK01065) cannot be considered as regular teachers and same was communicated to you vide letter ref. no. Teacher Verification/MARB/2024 dated 20.07.2024.
- Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the NCISM Act, 2020 and relevant Regulations thereunder. On careful examination of the assessment report it is found that your college is not fulfilling the notified and approved criteria due to the following shortcoming:-

Shortcoming:-

- a) Medical Superintendent Room Computer/ Printers both are not available.
- b) Quality Testing Lab is not available.
- c) Teaching staff :-

- d) Strirog does not have attached washrooms and lithotomy examination tables.
- e) Central computerized IPD patient registration system not working.
- 4. In view of above, the assessment report was placed in the 103rd Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) on 21.08.2024 & 22.08.2024. On careful examination of the assessment report, considering the deficiencies observed therein as mentioned above, the Board discussed and decided to provide an opportunity of virtual hearing vide the MARB-ISM letter (Hearing notice) of even number dated 30.08.2024 to appear before the designated Hearing Committee on 02.09.2024, to present their case and to show cause as to why not the conditional permission to the college with 60 seats in UG (BAMS) under section 28 of NCISM Act, 2020 be denied for the Academic Year 2024-25.
- 5. The college was directed to make written submission in respect of the case and produce all relevant valid documents/records/proof to substantiate the claims against all the deficiencies/shortcomings as indicated above. The representatives of the college submitted written submissions vide letter no. 270/SRVANCH/2024, dated 31.08.2024 against the deficiencies conveyed to them. Whereas, the college through its representatives, Dr. Satish Chandra Tiwari (Principal) and Dr. Deepak singh, associate professor, shalakya., appeared before the Hearing Committee on 02.09.2024 and made their submission virtually as well as written, against the shortcomings communicated to the college. 6. Further, Medical Assessment and Rating Board, NCSIM was in receipt of a letter vide ref no. SSAMCH/24/11 dated 20.08.2024 regarding the payment of imposed monetary penalty of Rs. 1 crore 50 Lakh to your college on the condition that your college should pay the penalty amount of Rs. 1 crore 50 Lakh in installments and same was placed in the 104th Board meeting of Medical Assessment and Rating Board, NCSIM held on 28.08.2024. Board accepted the request of the college to pay the monetary penalty of Rs. 1 crore 50 lakh in installments and same was communicated to you vide letter of even no. dated 03.09.2024.

- 7. Furthermore, as per Regulation 71(3)(a) of MESAR 2024 regarding "Imposition Monetary penalty not exceeding Rs. 1 Crore". Therefore, your monetary penalty of 1.25 crore has been revised to Rs. 1 crore and same was informed to you vide letter ref. no. Teacher Verification/MARB/2024 dated 09.10.2024. Further, the 1st installment of Rs. 25 Lakh has been received through RTGS no. UBINR2202408270108629 dated 27.08.2024.
- 8. Thereafter, the observation of hearing committee based on the submission made by the college representatives during hearing and assessment report of the NCISM have been carefully re-examined in terms of Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the NCISM Act, 2022 and relevant regulations thereunder, **and once again** the recommendation of Hearing Committee was placed in the **105**th **Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) **on 03.09.2024.**
- 9. Further, Board observed that the college was not fulfilling the basic eligibility criteria for issuance of conditional permission for UG (BAMS) Course under section 28 of NCISM Act 2020 for the Academic Session 2024-25 and decided to issue Conditional Permission for the UG course as per the approved Seat Reduction Policy in accordance of Section 28 (1) (f) of NCISM Act 2020 as college was having only 26 total eligible teaching faculties after considering Dr. Savita Choudhary (AYPK01065) Assistant Professor in the Panchkarma department as an eligible faculty as approved in 105th Board Meeting. Therefore, college was issued conditional permission with seat reduction for intake capacity of 54 seats [instead of 60 seats] in UG (BAMS) course for the academic session 2024-25 under section 28 of NCISM Act, 2020 and same was informed to you vide letter of even no. dated 06.09.2024.
- 10. Thereafter, a first appeal vide an email dated 08.11.2024 was received in the Commission NCISM from Dr. Chhaya T Munde (AYKS00517), Professor in the department of Kriya Sharir from your college regarding withdrawal of teacher code against the MARBISM letter vide ref. no. Teacher Verification/MARB/2024 dated 30.07.2024. Accordingly, hearing was held virtually on 14.11.2024 and the recommendation of the hearing committee was placed before the Chairman, NCISM and the Chairman, NCISM decided to consider the appeal of the faculty as a regular faculty in the college.
- 11. Further, the Chairman, NCISM directed the President, Medical Assessment and Rating Board for Indian System of Medicine, NCISM vide letter no. NCISM/Comm./Teacher Verification/(2024-25)-(UP) dated 26.11.2024 to consider Dr. Chhaya T. Munde as regular faculty in the college.
- 12. Therefore, after considering the above said faculty, Availability of total teaching staff is $\frac{Available}{Required}x100\% = \frac{27}{30}x100\% = 90\%$. Further, College is not fulfilling the notified & approved criteria, but fulfilling the criteria required for issuance of conditional permission as mentioned in Regulation 3 and as per the note mentioned in Schedule-V of MSR 2016.
- 13. Therefore, Conditional Permission is granted to Shri Ramchandra Vaidya Ayurvedic Medical College and Hospital, Yamuna Vihar, Malhaur Road, Near Eldico Tiraha, Chinhat, Lucknow-226028, Uttar Pradesh (Inst. ID-AYU0367) with intake capacity of 60 seats in UG (BAMS) course for the academic session 2024-25 under section 28 of NCISM Act, 2020 subject to the condition that college is fulfilling the following conditions as mentioned below: -
 - I. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
 - II. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 60 seats in UG Course shall be treated as All India Quota. The counseling for seats under All India Quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2024-25 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for All India Quota or the students admitted thereunder.
 - III. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatary Committee (FRC) of respective State/UT/Deemed to be University.
- 14. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
- 15. Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, the Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular or the subsequent academic year.
- 16. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- 17. The following requirements should be fulfilled by the college by 31st December, 2024 and compliance report should be sent to get permission for the academic session 2025-2026:

- All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be i) fulfilled in toto.
- All the requirements of minimum standard of infrastructure and teaching & training facilities as specified in MES ii) (Assessment & Rating for Undergraduate Ayurveda Colleges and Attached Teaching Hospitals) Regulations, 2024.
- (iii All the requirements of the National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education) Regulations, 2022.
- 18. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2025-26.
